Subject : Scheme of Appointment on Compassionate Grounds.

A Central Board for adjudication of the cases of appointment on compassionate grounds for the entire organization of PCA(Fys) Kolkata was constituted in order to find out the extreme deserving cases and to maintain uniformity in procedure within the available vacancy limit. Reference of PCA(Fys) Kolkata Important Circular No. 032/AN-II/Vol-XII dated 19/20-12/2001 may be invited in this regard (copy enclosed). Since then, cases for appointment on compassionate grounds are being adjudicated centrally at MO Kolkata to maintain uniformity as well as the vacancy position since it is not feasible to distribute Controller-wise the vacancy meant for compassionate appointment, released by the HQrs. Office from time to time.

For the deserving cases of appointment on compassionate grounds in Br. Accounts Offices, as adjudicated by the Board of Officers centrally at MO, PCA(Fys) Kolkata and recommendation of the Board being accepted by the Competent Authority in this regard, pre-appointment formalities including Selection Test, verification of character and antecedents etc are being initiated by the respective Br. Controllers and on completion of the ibid formalities, Offer of Appointment is being issued by the Br. Controllers being the Competent Appointing Authorities for Gr. C posts as per SRO dated 31.03.2001.

For the non-deserving cases of appointment on compassionate grounds in Br. Accounts Offices, it has now been decided by the PCA(Fys) Kolkata that henceforth necessary Speaking Orders detailing the reasons for rejection of request for appointment on compassionate grounds may also be issued to the applicant by the respective Br. Controllers being the Competent Appointing Authorities. The Speaking Order should be issued in accordance with the Draft Speaking Order approved by the Competent Authority at MO, PCA(Fys) Kolkata. Copy of the Speaking Order so issued to the applicant along with copy of the acknowledgement in token of having received the same by the applicant may be forwarded to this Office for record.

In view of the revised consolidated orders mentioned above (copy also endorsed to you) governing the scheme of compassionate appointment under Central Government, a Central Board at M.O. Calcutta has been constituted to adjudicate the cases of compassionate appointment and to dispose of the same as per laid down guidelines received from HQrs. office from time to time.

Hence, Board for consideration of compassionate appointment formulated at your end may please be ceased forthwith and all the requests for compassionate appointment received upto 31st DEC 2000 should be processed up to obtaining Objective Reports by Welfare Officer in the rank of IDAS Officer. The Objective Report should be very specific in terms of various Govt. orders received under HQrs. office letter Dated 05/12/2001 in respect of family size, liability, shelter of family, terminal benefits received, pension earnings, income from all source including agricultural income if any and merit of the case in terms of Planning Commission Index of Poverty Line.

The report should be self-contained bringing the clear picture about the dire and indigent circumstances of the family. After obtaining the report from the Welfare Officer, the same is to be reviewed by the Controller himself in the light of HQrs. office guidelines cited under reference and other information in this regard issued from time to time. The comment of the Controller should be specifically indicated in the report regarding applicability of deserving / not deserving case. Thereafter, case file of compassionate cases (separate) enclosing all documents relative to the cases. (Xerox copies duly attested by AO/SAO) may please be forwarded to this office so as to reach this office by 26-12-2001 positively for placing before the Central Board.

Similarly the cases of Compassionate Appointment received if any from JAN- 01 to DEC - 01 to be processed at your end and be forwarded to this office after hearing from this office.

The matter is very urgent and expeditious actions is therefore requested.
