**Subject : Grant of First Financial Upgradation under Modified Assured Career Progression Scheme to Clerks.**

The Principal Controller of Finance & Accounts (Fys), Kolkata hereby approves grant of First Financial Upgradation under MACP Scheme as introduced by Government of India vide DOPT's O. M. No. 35034/3/2008 – Estt.(D) dated 19/05/2009 and F No.35034/3/2015-Estt(D) dated 28.09.2016 for Central Govt. Civilian employees in respect of the **individuals mentioned in the annexure** in the (Pre-revised) scale of Rs. 5200-20200 with the grade pay of **Rs.2000** in the Pay Band – 1 (**corresponding to the pay level-3 of Pay Matrix under 7<sup>th</sup> CPC** ) w.e.f. **the date mentioned against them** as they have already completed 10 years of regular service.

The MACPS contemplates merely placement on personal basis in the immediate higher grade pay / grant of financial benefits only and shall not amount to actual / functional promotion of the concerned individuals and shall also have no relevance to their seniority position.

On their financial upgradation under MACP Scheme, their pay shall be fixed under the provision of FR 22(1) (a) (1) read with Deptt. of Expenditures OM No. 1-6/2016-IC(Pt) dated 29/09/2016. Individuals are, therefore, advised to exercise option towards fixation of pay, if any and furnish the same to the AN Pay Section of this office within the specified period.

**“In the event of any erroneous financial upgradation noticed at a later stage individual will be liable to refund the differences of Pay and Allowances to the department.”**

An undertaking to the effect has been accepted by the individuals and the same has been obtained and recorded.
