Subject : Grant of Third Financial Upgradation under MACP scheme to the Assistant Accounts Officer.

Controller of Finance & Accounts (Fys), Bolangir hereby approves grant of Third Financial Upgradation under MACP Scheme as introduced by Government of India vide DOPT's O. M. No. 35034/3/2008 – Estt.(D) dated 19/05/2009 and F.NO. 35034/3/2015- Estt.(D) dated 28.09.2016 for Central Govt. Civilian employees in respect of **Shri Prakash Chandra Khilar, AAO /8337343** serving in AO OF Bolangir in the pre-revised Pay Scale of Rs. 9300-34800 with the grade pay of Rs. 5400/- in the Pay Band – 2 (corresponding to 7th CPC pay matrix-9) w.e.f. the date **22.10.2019** as he has already completed 10 years service in the same grade pay from the date of 2nd promotion.

The MACPS contemplates merely placement on personal basis in the immediate higher grade pay / grant of financial benefits only and shall not amount to actual / functional promotion of the concerned individual and shall also have no relevance to his seniority position.

On his financial upgradation under MACP Scheme, his pay shall be fixed under the provision of FR 22(1) (a) (1) read with Deptt. of Expenditures OM No. 1-6/2016-IC(Pt) dated 29/09/2016. Individual is, therefore, advised to exercise option towards fixation of pay, if any and furnish the same to the AN Pay Section of this office within the specified period.

“In the event of any erroneous financial upgradation noticed at a later stage individual will be liable to refund the differences of Pay and Allowances to the department.”

An undertaking to the effect has been accepted by the individual and the same has been obtained and recorded.
