Subject: Grant of Third Financial Upgradation under MACP scheme to the Sr Auditors (Recruited as Auditor Fresh entrant)

The Principal Controller of Accounts (Fys), **Kolkata** hereby approves the grant of **Third** Financial Upgradation under MACP Scheme as introduced by Government of India vide DOPT's O. M. On his financial up gradation under MACP Scheme, individual's pay shall be fixed under the provision of FR 22(I) (a) (1) as per Deptt. Of Expenditures OM No. 1/1/2008(Pt.) dated 13/09/08 and OM No. 1-6/2016-IC (Pt.) dated 29/09/16. Individual(s) is/ are, therefore, advised to exercise option towards fixation of pay, if any and furnish the same to the AN Pay Section of this office within the specified period.

"In the event of any erroneous financial up gradation noticed at later stage, individual would be liable to refund the differences of Pay and Allowances to the Department."

An undertaking to this effect has been accepted by the individual and the same has been obtained and recorded.


